The purpose of this organization is to establish, promote, and perpetuate a Christian camp in northeastern Indiana to provide for youth a wholesome environment and recreation under the guidance and supervision of Christians while instructing the youth in the knowledge of God's word

Code of Bylaws of Camp Indogan, Inc., Article I, Section 2

Activities:

Campers will participate in daily Bible classes, chapel, singing, campfires, and mail call. Recreation includes softball, Ping-Pong, swimming, basketball, volleyball, tetherball, games, skits, and banquet night.

What to Bring:

Campers should bring an old Bible, bedding, a modest swimsuit (no bikinis), notebook, pencil, flashlight, jacket, towels, sneakers, toiletries, and clothing. Shorts must be at least three-quarters the length of the thigh. No tank tops, muscle shirts, low-cut, or sheer lace will be allowed. Sleeveless shirts must be no less than three inches in width. All clothing must cover undergarments.

Do not bring cell phones, electronic devices, or valuable jewelry. Pets, drugs, knives, axes, firearms, firecrackers, and musical instruments are prohibited for campers and visitors of the camp.

Camp Contract

It is the goal of Camp Indogan to provide a week of Christian education, fun, and fellowship.

We want this week to provoke growth for both campers and staff. In order to ensure this environment, some rules are necessary.

1. I will attend all activities planned by the camp staff.
2. I understand that girls must not be around the boys' cabins and boys must not be around the girls' cabins.
3. I will help keep my cabin and grounds neat and clean, participating in scheduled clean-up times.
4. I will follow the camp rules concerning the clothing modesty requirements. I will not engage in provocative and/or immodest speech or activities.
5. I will abide by camp prohibitions.

7. I will check-in all medicines with the camp nurse.
8. I will not go to my cabin without permission from a counselor.
